JAMS, The Resolution Experts, is the largest private *alternative dispute resolution* (ADR) provider in the world. Their mission is in their name: to be the resolution experts – to provide "the highest quality dispute resolution services to our clients and to our local, national, and global communities." Striving for "uncompromising neutrality, and the highest ethical standards," they resolve complex legal disputes through mediation and arbitration.

By the nature of their mission, it is easy to understand why JAMS would be concerned with the integrity and availability of information. With more than 250 full-time neutrals, 190 employee associates, and a large case load, JAMS has complex reporting needs. By corporate standards, JAMS seems small, but it is an organization that is extremely information-driven.

CHALLENGE:

Each month, using SAP Business Objects Edge, JAMS schedules over 400 Crystal and Web Intelligence Reports to more than 50 internal information consumers in operations, senior management, and marketing. These information consumers need the timely, complete and accurate information provided by these reports to make critical business decisions that live up to their uncompromising neutrality and high ethical standards.
